**1. ACKNOWLEDGEMENT OF RISK.** Participant, Parent(s) and/or Legal Guardian(s) acknowledge and fully understand there are inherent risks of serious injury or death associated with vigorous physical activity such as running. These inherent risks include falls, encountering natural dangers such as falling rocks or objects, irregular or uneven ground, or unseen and unmarked objects. Inherent risks also include acts or omissions of other participants; the condition of equipment or property, the road, track, or trails; weather conditions (such as lightning strikes, sunburn, rain or hail storms, tornadoes, and the like); contact with plants, animals or insects; the risk of participant engaging in unauthorized activities; Participant's physical condition; Participant's own acts and omissions; conditions of roads, trails, waterways or terrain; the administration and availability of first aid and emergency treatment; and consumption of food or drink by Participant. Participant, Parent(s) and/or Legal Guardian(s) further acknowledge that all inherent risks associated with such activities cannot be described in this document.

**2. ADDITIONAL ACKNOWLEDGEMENTS.** I authorize and empower the coaches to authorize any medical care or treatment for the minor that may appear reasonably necessary as a result of emergency, accident, or illness whether occurring before, during, or after an event. I also give permission to the Eagles to use any photographs, motion pictures, recordings, or the like for any legitimate purpose.

**3. PARTICIPANT WAIVER OF RIGHTS AND RELEASE OF LIABILITY.** Participant, Parent(s) and/or Legal Guardian(s) hereby release, waive, discharge and covenant not to sue EAGLES Team, its coaches, assistant coaches, officers, advisors, and/or volunteers (collectively, the "EAGLES Releasees") from all liability to the Participant, Parent(s), and/or Legal Guardian(s), their personal representatives, assigns, heirs and next of kin, for any and all loss or damage, and any claim or demands therefore, on account of injury to the person or property or resulting in the death of Participant, Parent(s) and/or Legal Guardian(s), arising out of or related to participation in EAGLES programs, events or retreats, including but not limited to those risks described in paragraph 1 above, or otherwise. **5. UNIFORM ISSUE.** Used MS singlets are issued and are to be returned at the end each season for return of MS issue fee.
